

# WASTEWATER SURVEILLANCE TIME-LIMITED WORKING GROUP TERMS OF REFERENCE

## Version 1 – September 2023

## AIM

To discuss and harmonise approaches to wastewater pathogen genomic surveillance across Australia and New Zealand to support the development of best practice methodologies.

## ACTIVITIES

- 1. Compare approaches to wastewater surveillance activities across jurisdictions, from extraction methodology through to reporting structure
- 2. Explore opportunities for funding and to increase the scope to surveillance for other pathogens and AMR
- 3. Review and harmonise reporting methods and formats
- 4. Develop a wastewater surveillance position statement reflecting best practice approaches across Australia and New Zealand, and aligning with international wastewater surveillance practices where appropriate

## GOVERNANCE

This is a time limited Working Group (WG) of the CDGN, and will operate until the finalisation of a position statement, or at a time deemed appropriate by the WG. The WG will be reviewed on a bi-monthly basis.
